About

This dataset is from the [WHO Health Inequality Data Repository](#).

This dataset contains migration indicators in European countries related to health status, health behaviours and risk factors, health care and health determinants (housing conditions, income distribution, poverty and material deprivation). The dataset "Indicators disaggregated by migratory status" (*mig1*) contains data disaggregated by migratory status; the dataset "Indicators among people who are migrants" (*mig2*) contains data disaggregated by age, sex and type of migrant.

Eurostat produces European statistics in partnership with National Statistical Institutes and other national authorities in the EU Member States. This partnership is known as the European Statistical System (ESS). It also includes the statistical authorities of the European Economic Area (EEA) countries and Switzerland.

Data source

Data were downloaded from the Eurostat data browser (<https://ec.europa.eu/eurostat/databrowser>) via the [SDMX API](#), within the Migration integration > Health theme. These indicators are originally sourced from the European Health Interview Survey (EHIS) and the EU Statistics on Income and Living Conditions survey (EU-SILC).

Methodology

The general coverage of the EHIS is the population aged 15 or over, while the coverage of EU-SILC is the population aged 16 or over.

Inequality dimensions

Age refers to the age of the respondent at the time of the survey, grouped in six subgroups: 16-24 years (or 15-24 years), 25-34 years, 35-44 years, 45-55 years, 55-64 years and 65+ years.

Migratory status refers to whether the respondent is a non-migrant or a migrant (based on either having a country of birth or country of citizenship that is not the same as the country of residence).

Sex refers to the male or female sex of the respondent.

Type of migrant refers to whether the migrant is from another EU country (EU migrant) or a non-EU country (Non-EU migrant), based on either their country of birth or their country of citizenship.
